1. Call the meeting to order.
2. Roll call.
3. Consideration, discussion and possible action on Notice of Election under and by virtue of Title 68 Oklahoma Statutes Section 1370 and the order of the Board of County Commissioners of Kay County, State of Oklahoma, for the purpose of levying and assessing a one-third of one cent (1/3 of 1%) county sales tax to provide revenues to participating volunteer, combination and paid fire departments, associations, or services, and participating municipal emergency medical services, approved by the Board of County Commissioners of Kay County, Oklahoma, on the 22nd day of August, 2022.
4. Consideration, discussion and possible action on an order authorizing the calling and holding of an election in Kay County, State of Oklahoma for the purpose of submitting to the registered qualified voters of said county the question of approval or disapproval by said voters of a levy and assessment of an additional one-third on one percent (1/3 of 1%) county sales tax upon the gross proceeds or gross receipts derived from all sales taxable under the Oklahoma Sales Tax Code, commencing January 1, 2023 and ending December 31, 2028 and containing other provisions relating thereto. This order determines the date of the vote.
