Monday, May 15, 2023 Newkirk, Oklahoma

The Board of County Commissioners (BOCC) of Kay County, Oklahoma, met in regular session at 9:00 o'clock a.m. on Monday, May 15, 2023, the meeting was posted for public information on May 12, 2023, at 8:50 a.m. at the Commissioners Room, west entrance of the Kay County Administration Building in Newkirk, Oklahoma, and on the Kay County Website.

Chairman Shane Jones called the meeting to order: Commissioners: Jason Shanks, Member, present; Jeff Kreger, Member, present. Others present were as follows: Brian Hermanson, Kay County District Attorney (DA); Don Jones, Kay County Detention Center Director; Dennis Bonewell, Emergency Management; Brenda Medlock and Shannon Mallory, OSU Extension; Donna Parker, Oklahoma Court Services; Dan Hesson, Kaw Nation; Everett Brazil, Newkirk Herald Journal; Claude Williams, Taxpayers for Transparency; Tammy Reese, Secretary/Kay County Clerk.

Chairman Shane Jones led the flag salute.

Motion was made by Kreger and seconded by Shanks approving the regular meeting minutes of May 8, 2023. Motion carried: Kreger, aye; Jones, aye; Shanks, aye.

Report was given by Donna Parker, Oklahoma Court Services, presenting the number of community service hours defendants are working and the projects they are involved in: Ms. Parker gave the following report for April 2023: New community service clients-23, regular community service clients turned in for the month-60, sanction community service ours completed-256.5, total hour completed-1069, and community service offender completions-12. Completed Events: Blackwell Cemetery-clients assisted with mowing and weed-eating; New Life Trails-clients assisted with yard work; Friendship Feast-clients with preparing sack meals; Blackwell Public Library-clients assisted with cleaning and dusting shelves; Ponca City Disc Golf-clients assisted with cleaning the parks. Upcoming Events: Blackwell Schools, Lake Ponca, Northern Oklahoma Humane Society, and Tonkawa Cemetery where clients will assist with many various duties.

OSU Extension April reporting on programming, contests, and events: Brenda Medlock stated they have not hired a 4-H Agent but will be interviewing in the near future for that position. Medlock said State 4-H Vice-President Colton Tripp and his brother Cash were amongst 4-H'ers and state leaders at 4-H Day at the Capitol. Secretary of Agriculture Blayne Arthur addressed the group. Medlock said OSU Extensions' received two grants, one was for \$8 million and one was for \$3 million; she said one is a three-year grant and the other is a five-year grant. Medlock told she will be able to hire more people with the use of these grants; she said "Fatherhood" and "Health Education" will be the two topics the new hires will lead. Medlock talked about the 4-H Food Showdown and Bread Show Contest that was held on April 22nd. She said the teams prepared a dish from three (3) secret ingredients and used a common pantry. The teams make a presentation to the judges that shows their knowledge of nutrition, the cost of the dish, food safety, serving sizes, and teamwork. The Bread Show has 13 different categories that 4-H youth can enter premade to be judged by taste and quality. Medlock also talked about the OHCE Food Show Contest that was held on April 27th, the theme was "Mexican Fiesta". She said there were six categories and the judging was based on nutrition, taste, attention to the team, and garnishings. The champion was Nardin OHCE and the Reserve Champion was the Kildare OHCE group.

Shannon Mallory said April was a very busy month. He talked about a Cimmaron Ag Conference that was held on April 4th in Perry for producers to receive six (6) continuing education credits and a pasture training was held on April 6th to receive three (3) continuing education credits by Zoom in Kay County. He told that the Master Gardeners helped students at Washington School make dirt babies; he said about 240 students made their dirt babies and added the Master Gardeners enjoy their school enrichment activities. Mallory said the Master Gardeners sold about \$14,000 worth of flowers this spring and said 40% goes back to the Master Gardeners. Mallory taught students at Peckham School about chickens; he said teachers and students hatched 20 baby chicks in an incubator as part of a Chick Embryo Program. He told the Junior Livestock planning has begun and stated they are proposing some new rules. He said this next year they may want a live auction again for the livestock show fundraiser. Mallory said Don Schieber will host Wheat Field Day on May 23rd beginning with a breakfast at 8 a.m. and a program at 9 a.m.; he told there would be some great speakers and education presented.

Motion was made by Kreger and seconded by Shanks approving to purchase outdoor benches from OCI for the west side of the Administration Building, to be paid from the General Government account. Motion carried: Kreger, aye; Jones, aye; Shanks, aye.

ARPA funding to purchase a Corre Trak Mobile Inmate Tracking System: Don Jones, KCDC Director, said BOCC approved this expenditure about a year ago. Jones explained the system and its uses and told the one he originally was looking at was about \$25,000 higher than this one.

Motion was made by Shanks and seconded by Kreger approving using ARPA funding to purchase a Corre Trak Mobile Inmate Tracking System off of the Sourcewell Contract #081419-SHI for the Kay County Detention Center. Motion carried: Kreger, aye; Jones, aye; Shanks, aye.

Road and Bridge Projects/Circuit Engineering District (CED) No. 8 Road and Bridge Projects: Commissioner Jones said crews hauled sand out of ditches and off the road on County Lane Rd., patched on asphalt roads, boom mowed on Lake and Pecan Rds., hauled material to roads, and graded.

Commissioner Shanks said crews will be working in the shop all week.

Commissioner Kreger said crews dug shale at the pit, hauled Sober rock and crusher to the yard, cleaned ditches and tree rows, laid shale and rock on roads, graded, and took FEMA pictures to close out PW 996. Also, he said Sober hauled crusher to the yard.

Motion was made by Shanks and seconded by Jones approving recommending CED#8 to the Oklahoma Department of Transportation as Kay County's selection of a Consulting Engineer for Kay County District #1, Project JP# 38110, Project Description CN 244. Motion carried: Kreger, aye; Jones, aye; Shanks, aye.

Motion was made by Kreger and seconded by Shanks approving using ARPA funding (\$355,444.00) to purchase a John Deere 672G Motor Grader with 6WD, Sourcewell #03-2119-JDC, Dist#3. Motion carried: Kreger, aye; Jones, aye; Shanks, aye.

Motion was made by Shanks and seconded by Jones approving the following Kay County Monthly Reports for April 2023: County Clerk; Health Department. Motion carried: Kreger, aye; Jones, aye; Shanks, aye.

Motion was made by Shanks and seconded by Kreger approving the following Transfer of Appropriations/Transfer of Funds: Assessor Visual Inspection Personal Service-\$5,000.00 to Maintenance & Operations; OSU Extension Contractual Services-\$5,000.00 to Capital Outlay; CBRI-\$250,000.00/FEMA Projects-\$89,875.00 Total of \$339,875.00, Hwy. Dist#3 to Coleman Rd. River Embankment Project. Motion carried: Kreger, aye; Jones, aye; Shanks, aye.
